电动工具通用安全警告

工作场地的安全

- ▶ 保持工作场地清洁和明亮。混乱和黑暗的场地会引发事故。
- ▶ 不要在易爆环境,如有易燃液体、气体或粉尘的 环境下操作电动工具。电动工具产生的火花会点 燃粉尘或气体。
- ▶ 让儿童和旁观者离开后操作电动工具。注意力不 集中会使操作者失去对工具的控制。

电气安全

- ▶ 电动工具插头必须与插座相配。绝不能以任何方式改装插头。需接地的电动工具不能使用任何转换插头。未经改装的插头和相配的插座将减少电击危险。

安装

辅助手柄

▶ 操作电动工具时务必使用辅助手柄(4)。

可以任意翻动辅助手柄(4),以便在工作时毫无疲劳 地牢牢抓紧。

- 松开滚花螺母(**5**),将辅助手柄(**4**)翻动至所需位置,然后再次拧紧滚花螺母(**5**)。

可以改装辅助手柄(4)。

- 拧下滚花螺母(5), 然后将六角螺栓向上拔出。

更换工具




